



## Vallecitos goes BIG on Renewable Energy

The Vallecitos Water District's Board of Directors has long expressed interest in renewable energy. Some of these ongoing plans are reaching fruition. The District is installing new photovoltaic systems at our Twin Oaks Reservoirs 1 and 2 as well as at our Lift Station #1 (LS1) location along San Marcos Boulevard.

The combined systems are designed to produce over 3.5 million kWh in the first year. The District approved an agreement with the solar provider that maintains a price per kWh for all energy produced (7.79 cents/kWh) and the price never increases over the life of the system, unlike local energy utility

rates, which increase at about 3% every year and range from 15 to 80 cents/kWh.

Vallecitos' first year energy savings are estimated at approximately \$105,000. There were also no upfront costs for Vallecitos. Over a 25-year period, because of escalating energy costs, Vallecitos' estimates a savings of \$8,300,000. These energy savings will assist the District in keeping our water and sewer rates as low as possible moving forward.



The system at LS1 will offset approximately 90% of the energy demand at that location. The larger system at Twin Oaks Reservoirs will offset approximately 57% of the remainder of our system electricity demand.

Vallecitos initially installed a solar carport project back in 2006 at our Administrative, Operations and Maintenance Facility located at 201 Vallecitos de Oro in San Marcos. The solar carport project is still operational and provides approximately 90% of the energy costs at the facility each year.

While the cost savings of the solar projects make financial sense, we think you will agree that reducing the production of Carbon Dioxide, Nitrogen Oxide, and Sulphur Dioxide also makes a better world. Video about this project can be found here: https://www.youtube.com/watch?v=fhEqGMI7n0Q.

## Vallecitos Receives Award for Financial Reporting



The Government Finance Officers
Association of the United States and
Canada (GFOA) has awarded the
Certificate of Achievement for Excellence
in Financial Reporting to Vallecitos Water
District for its comprehensive annual
financial report (CAFR) for the fiscal year
ending June 30, 2019. This is the first
CAFR the District has ever produced.

The CAFR has been judged by an impartial panel to meet the high standards of the program, which includes demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story and

motivate potential users and user groups to read the CAFR.

The Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

## **Fitch**Ratings

Prudent financial planning and reasonable assumptions in an uncertain global environment result in Fitch Ratings recently reaffirming Vallecitos Water District's credit rating of 'AA+', with a "Stable Outlook" into the foreseeable future.

Fitch's analysis determined the factors for the favorable rating to be:

- Very strong revenue defensibility
- Low operating risk profile
- Favorable service area
- Affordable rates
- Sound debt coverage and liquidity levels

Vallecitos' rating was bolstered by an informed forecast pointing to continued solid performance. The AA+ rating is a testament to the actions taken by the Vallecitos Board to ensure that Vallecitos is properly run financially.

# Vallecitos Recognized for Best Safety Practices

Vallecitos Water District was among 16 California water agencies honored by the Association of California Water Agencies Joint Powers Insurance Authority (JPIA) with the H.R. LaBounty Safety Award.

Vallecitos won its award for its Confined Space Rescue Training coordinated with several regional fire agencies in November 2019. Vallecitos Water District wanted to heighten safety awareness and improve procedures in its confined space entry and rescue during real-world situations. It took a high level of coordination to bring in fire department personnel to conduct 12 days of joint training.

As a result of training, personnel were able to reduce potential hazards conducting entry into confined spaces, perform personnel rescues, and better manage hazardous materials present (gaseous chlorine).

Wastewater Treatment Plant Supervisor Dawn McDougle, Senior Wastewater Treatment Plant Operator Matt Wiese, Wastewater Treatment Plant Operators II Chris Deering, Ivan Murguia, Arturo Sanchez, and Marc Smith, Safety Technician Anette Longville, and Public Information Officer Alicia Yerman were recognized for their roles in organizing and conducting the training.

Further, Vallecitos' Wastewater Collections Crew, which serves as the District's Confined Spaces Rescue Team, participated in this training alongside fire crews. Fire department crews were from the cities of Carlsbad, San Marcos, Del Mar, Vista, Escondido, Oceanside, Encinitas, Solana Beach, Rancho Santa Fe, Valley Center, and crews from North County Fire (Fallbrook), San Pasqual, Rincon, and Camp Pendleton.

The H.R. LaBounty Safety Award Program is designed for all JPIA members as a way to promote safe workplace behavior and operations practices while rewarding those employees who demonstrate safe behavior, take part in recognizable proactive activities, or participate in risk-reducing actions. It gives members another way to foster a safety culture that reduces the potential for losses. The Ramona Municipal Water District and the Sweetwater Authority were also recognized among state water agencies for their safety initiatives.


