ITEM(S) FOR DISCUSSION

LEGAL SERVICES AGREEMENT EXTENSION

General Manager Pruim stated the District entered into an agreement for legal services with Best & Krieger (BBK) on March 21, 2018, for an initial three-year term with two one-year extension provisions until March 1, 2023. The current agreement expired on March 1, 2021. Legal Counsel Gilpin has indicated there is no problem continuing the lapsed agreement with the same terms and conditions; however, it is prudent to make an official decision on whether to exercise the first provision to extend the contract to March 1, 2022, and at that time decide on exercising the second provision to extend the contract to March 1, 2023. General Manager Pruim recommended exercising the first one-year extension to March 1, 2022.

General discussion took place regarding the work BBK has been doing for the District. General Manager Pruim will provide the Committee a list of issues BBK has worked on for each of the three years BBK has represented the District as well as current projects and a list of agencies in San Diego County that BBK represents. An item to exercise the first provision for a one-year extension to March 1, 2022, will be placed on the consent calendar of the July 21, 2021, Board agenda.

General Manager Pruim further stated it is the District's policy to evaluate professional service agreements valued over \$100,000 per year competitively at least every five years. It would be prudent to review the BBK contract before it expires on March 1, 2023, if the second provision to extend the contract is exercised. The Committee agreed with this. A meeting of this Committee will be scheduled in November of 2021 to discuss whether or not to exercise the second provision to extend the agreement to March 1, 2023, and the Request For Proposal process for legal services.
