UPDATE ON WATER COST OF SERVICE STUDY

General Manager Pruim stated that whenever an agency is considering raising its rates, it must follow a well-defined process to ensure the public is well informed and has an opportunity to provide input. Preparation of a Cost of Service Study (COSS) is one part of the process.

General Manager Pruim further stated it has been a year and a half since the District last increased rates. The purpose of this item was to provide the Board with an update on the COSS to date and for the Board to provide direction to staff on how to proceed with the completion of the COSS and the rate setting process.

Principal Financial Analyst Arthur and John Wright of Raftelis facilitated a presentation on the COSS Update/Scenarios as follows:

General discussion and question and answer took place during the presentation.

Gayle Martin, member of the public, asked if an HOA falls into Tier 3 and how many people comprise an average single family residence. Staff responded to her questions and Director Sannella offered to meet with her to review her monthly bill.

General Manager Pruim clarified that the Proposition 218 process is for water rates only. Staff anticipates no change in sewer rates.

Further general discussion took place regarding the three scenarios presented. The consensus of the Board was to direct staff to pursue the third scenario, Property Tax/RDA Offset, with option C, 88.5% to Tier 1 and 11.5% to Tier 2.

WATER SERVICE SHUT-OFF MORATORIUM

General Manager Pruim stated the District curtailed shut-offs of water and wastewater service for non-payment in February 2020, ahead of the Governor's Executive Order N-42-20 prohibiting shut offs that was issued in April 2020. The executive order was scheduled to terminate on September 30, 2021. At the September 15, 2021, Board meeting, the Board directed staff to resume pre-COVID practices regarding shut-offs for non-payment if the executive order was not extended past September 30, 2021. Senate Bill 155, signed into law on September 23, extended the shut off prohibition until at least December 31, 2021.

General Manager Pruim further stated staff will resume its normal shut off practices when allowed to on January 1, 2022. As a participant in the state's arrearages program to assist customers who fell behind on their bills, the District must credit those customers with any funds received from the arrearages program, provide them the opportunity to set up a payment plan, and give them 30 days to make payment arrangements. After 30 days, if no payment arrangement has been made, the District can proceed with normal shut off procedures.

This item was presented for information only.

2022 STRATEGIC PLAN

Public Information/Conservation Supervisor Robbins stated the Board received a presentation on the 2022 Strategic Plan on November 3, 2021. At that time the Board requested text related to climate change be added in two places in Strategic Focus Area 6, Environmental Stewardship, and also requested additional options for a new Vision Statement. The placement of the added text and seven options for the Vision Statement were reviewed.

General discussion took place. The consensus of the Board was for the Vision Statement to state: To be a best-in-class utility for "One Water."

Staff recommended the Board adopt the 2022 Strategic Plan with the modifications and Vision Statement as discussed.

REPORTS

GENERAL MANAGER

COUNCIL (SDNEDC)

General Manager Pruim reported the following:

- Construction Inspection Supervisor Lee Kirby will be retiring from the District on December 30 with 22 years of service.
- The City of San Marcos General Plan Advisory Committee will meet on December 16 at 6:00 p.m. at the City's Community Services Building, 3 Civic Center Drive.

- The City of San Marcos will be issuing a proclamation to the District on January 11, 2022 to acknowledge the District's assistance with installation of hydration stations in several of the City's parks. The District secured grant funds to purchase the bottle filling devices. President Elitharp will accept the proclamation on the District's behalf.
- Staff has initiated the process to issue refunds of the proceeds (approximately \$1.25 million) from the lawsuits between San Diego County Water Authority and Metropolitan Water District of Southern California. The refunds will show as credits on customer bills. The process should be completed by January 12.
- The January 5, 2022, Board meeting is cancelled due to its close proximity to the holidays. The meeting may be rescheduled to January 12 if the Board is available. The January 19 Board meeting will be cancelled due to lack of a quorum as three Board members will be attending the CASA Winter Conference on that day.

DISTRICT LEGAL COUNSEL

Legal Counsel Gilpin provided an update on the Kessner litigation, a state-wide Proposition 218 case. The District is one of 82 defendants. A hearing was held last Thursday regarding a motion to dismiss that Best & Krieger filed on behalf of the District and five other agencies in San Diego County. A tentative ruling was made to dismiss the lawsuit.

SAN DIEGO COUNTY WATER AUTHORITY

Director Elitharp stated the CWA Board has scheduled a Special Meeting on December 16 to consider extending remote Board meetings.

ENCINA WASTEWATER AUTHORITY

Director Hernandez reported the Capital Improvement Committee approved a change order for the primary area improvement project at their December 8 meeting.

Director Sannella reported on the action taken by the EWA Board regarding COVID vaccination incentives for their employees.

Director Hernandez announced that Scott McClellan was selected to be the new EWA General Manager.

STANDING COMMITTEES

Director Elitharp stated the Engineering/Equipment Committee met on December 6. The Committee received updates on several projects.

Director Hernandez stated the Hillside Property Development Ad Hoc Committee met on December 7. An update will be provided to the Board in February.

Director Boyd-Hodgson stated the January 3, 2022, Public Awareness/Personnel/Policy Committee meeting has been rescheduled to January 10, 2022.
