General Manager Pruim informed the Board that agreements for the requested easements have been reached between the District and the parties and that Board action was not required for this item.

ACTION ITEM(S)

APPROVE PAYMENT FOR EMERGENCY REPAIR OF 14" WATER MAIN ON SAN MARCOS BOULEVARD

Asset Management Supervisor Bennett informed the Board that on August 17, 2022, around 3:00 p.m., staff responded to a water main leak at 1300 San Marcos Boulevard between Discovery Street and Pacific Street. After careful investigation, it was determined the main leak was behind sidewalk on a 14-inch Prestressed Concrete Cylinder Pipe (PCCP) water main. Staff was able to isolate the 14-inch water main on San Marcos Boulevard and distributed bottled water to the customers impacted by the shutdown and repair.

Asset Management Supervisor Bennett informed the Board that an outside contracting company, Cass Arrieta, was retained to perform the repair of the 14-inch PCCP under the District's emergency purchasing policy.

Staff recommended the Board approve payment to Cass Arrieta in the amount of \$56,454.76 for the emergency repair.

General discussion took place.

General Manager Pruim reported on the following:

- District staff will be performing a warranty video inspection on the San Marcos Sewer Interceptor Line this evening.
- San Marcos City Council is expected to approve the South Lake Agreement at its December 13, 2022, meeting.

General Manager Pruim congratulated Director Sannella on his campaign victory and thanked him for his years of service to the District.
