ACTION ITEMS

APPROVAL OF CONSTRUCTION CHANGE ORDERS FOR THE DISCOVERY STREET SEWER PROJECT

General Manager Lamb reported that the District has completed the Discovery Street sewer project. The authorization to construct included funds for Change Orders as approved in current policy. Two additional Change Orders arose, 9B and 10, which exceeds the Ordinance's construction contingency allowance. In order to maintain the construction schedule and avoid delay charges by Utah Pacific, staff signed these change orders, which made the total percentage slightly over the Ordinance percentage but still within the overall project budget. The change orders were not previously presented to the Board due to the timing of Board/Committee meetings and the imminent completion of the work. The costs for Change Orders No. 9B and 10 are \$24,812. A modification to the budget is not required as the project as a whole is under budget by approximately \$163,000.

Staff recommended approval of Change Orders No. 9B and 10 to Utah Pacific Construction's contract in the amount of \$24,812.00 for the Discovery Street sewer project.
