REVIEW OF DRAFT UPDATED EMPLOYEE HANDBOOK

Director of Human Resources Caudle presented and reviewed all proposed changes to the revised draft employee handbook. The proposed document has been reviewed by management and legal counsel.

Brief, general discussion took place.

PRESENTATION ON VALLECITOS WATER DISTRICT REORGANIZATION

General Manager Lamb reported that the current organizational structure is based upon a reorganization approved by the Board of Directors on November 10, 2008. The proposed reorganization furthers the Board's desire for cost efficiency while maintaining adequate staffing for efficient operation of the District which can be met through the following goals: 1) centralize employees that provide general support services under one Department; 2) ensure reasonable ratio of managers/supervisors/staff; and, 3) verify the need for current and future positions. One goal of this reorganization is to centralize employees who provide internal support to all departments, i.e. Information

Technology, Public Information/Conservation, Safety, Risk Management, Human Resources, administrative support, etc.

The proposed reorganization considers the number of managers and supervisors as well as the ratio of managers/supervisors/employees. A supervisor/employee ratio of 5 or 6 to 1 is a reasonable ratio to ensure proper supervision, however, ratios can be higher dependent upon the positions. This structure more fully utilizes the expertise and abilities of the existing managers and supervisors without sacrificing efficiency or placing an undue burden on any department.

The proposed reorganization will result in a reduction in annual operating costs of approximately \$225,000.

General Manager Lamb reviewed and discussed all changes in the proposed District reorganization. Brief, general discussion followed.

This item was for information and will be presented to the Board for consideration and approval at the regular Board meeting scheduled on March 17, 2010.
