COMMITTEE ITEMS

PRESENTATION BY SAN MARCOS UNIFIED SCHOOL DISTRICT (SMUSD) SUPERINTENDENT KEVIN HOLT ON THEIR PROPOSED BOND ISSUE

Superintendent Kevin Holt introduced SMUSD Board President Becky Garrett. Mr. Holt provided an overview on SMUSD and discussed challenges their District is currently facing. On July 12, 2010, their Board agreed to move forward with a general obligation bond measure for the November 2, 2010, ballot. This is a \$287 million bond - \$45 million is local dollars, \$45 million is SMUSD funds toward facilities, SMUSD is projecting \$55 million in State matching funds. This equals \$380 million total worth of modernization projects and touches every school in the district. The bond, if passed, will allow their District to receive State matching funds. It is expected to cost property owners approximately \$40 per \$100,000 of the assessed value of their property (average assessed value is \$300,000) which would amount to approximately \$120 per year for the general obligation bond. Taxpayer protection is built into the measure; the funds can only be used for facilities and the money stays local. Three phone surveys were conducted in the community; there is strong support in the community for the bond measure.

PROPOSED REVISIONS TO THE RESERVE POLICY

Finance Manager Scaglione stated that in 2009 staff reviewed the policy but did not recommend changes. Operating reserves of three to six months of budgeted operating expenses, excluding wholesale water purchase, is commonly recommended by industry consultants and organizations. Staff is proposing to revise the Reserve Policy to eliminate water purchases from the operating expenses and increase the reserve from 90 to 150 days of other expenses. The proposed revisions will reduce the overall reserves by approximately \$1.4 million and more evenly distribute the burden between the water and sewer funds. There is no immediate fiscal impact since the reserve levels are considered during the rate setting process when more equitable rate distribution between funds can be realized. Also, when securing debt financing, the lower reserve level is more achievable, and the widely recognized parameters would be viewed favourably by rating agencies, possibly resulting in a lower cost of debt.

Staff proposed the Committee recommend the full Board consider adopting the revised Statement of Reserve Policy Resolution.

The Board Committee recommended this item be presented to the full Board for consideration and approval.

OTHER BUSINESS

Public Information/Conservation Supervisor Urabe provided an update on the Demonstration Garden Project as follows:

- Rain barrels were installed a couple of weeks ago
- The white PVC pipes which were installed will be painted
- The plant material is scheduled to be removed this Friday
- The City of San Marcos is requiring a permit for the shade structure due to safety issues – the City has certain height restrictions; District staff is working with City staff
- The plants are scheduled to be planted mid to late September
- Waiting on the core driller he is out of state (he will drill the holes in the boulders for the water features); KRC liked the boulders that were onsite
- Getting a lot of publicity on the garden there was an article in the UT, article in the ACWA Newsletter, and a reporter from NC Times wants to attend the Open House to do a feature story

General Manager Lamb stated that staff is working on the Open House and has been discussing having guest speakers to discuss fire scapings, native plant gardening, and rainwater harvesting.
