# RECOMMENDATION FOR PERMANENT OFFSITE WATER SERVICE FOR PROPOSED PARCEL 2 APN: 178-180-34 (RIMSA)

General Manager Lamb stated that a request for permanent offsite water service has been submitted. This request was presented at the November 8 Board Committee meeting.

The existing residence currently receives water service from the District through an existing 1-1/2" meter located on Camino Calafia. The existing residence is located on the proposed Parcel 2. Upon approval of the proposed lot-split that is currently being processed with the County of San Diego, Parcel 1 will have frontage along the existing water main but Parcel 2 will not have frontage along a District water main. There are no properties located to the east which will require service in the future. Therefore, it is not feasible to extend District water facilities to the east across the frontage of Parcel 2.

Obtaining an easement south through the subject property provides an opportunity to construct a new water main in the future with the ability to provide better water pressure to those properties to the south.

Staff recommended approval for permanent offsite water service with conditions.

10-11-06 MOTION WAS MADE by Director Poltl, seconded by Director Gentry, and carried unanimously, with Director Hannan absent, to approve permanent offsite water service with the following conditions:

- 1. Payment of Permanent Offsite water service fee per Ordinance No. 118.
- 2. Submit proof of recorded easement across Parcel 1 for a private water service line to serve Parcel 2.
- 3. Submit proof of recorded easement dedicated to Vallecitos Water District for future water main extension. Easement must be located along the entire west property line from the existing District easement to the south property line. Easement must be 20-feet wide minimum.

#### <u>REPORTS</u>

#### **GENERAL MANAGER**

General Manager Lamb stated that a presentation was made at the Council of Water Utilities meeting yesterday by Kelly Salt of Best, Best, and Krieger regarding the impacts of Proposition 26 on local agencies. He has passed the presentation on to Legal Counsel Scott and this issue will be presented to the Board either in December or January.

General Manager Lamb stated that Mike Lee, of the Union Tribune, has requested additional information of the San Diego County Water Authority on Board members for FY 09/10 (travel reimbursement, per diem, etc.). He has also expanded his reporting efforts on public agencies to include sewer agencies.

General Manager Lamb stated that a coalition has been formed in North County with respect to reclaimed water service. This Board's Integrated Resources Water Plan calls for continued monitoring of reclaimed water issues. Staff is anticipating more and more issues associated with ocean discharge and in approximately 10 years, there is a very high likelihood of reduced discharges to the ocean. When the Coalition first started, there were only four or five members; the number has increased to eleven members, which are basically made up of the entire north county. He and staff member James Gumpel attended a meeting of the Coalition today. Preliminary work has taken place to date and the District has contributed \$10,000-\$12,000 towards the initial study. The entire project will cost anywhere from \$80 - \$390 million and is moving forward at a planning/ concept level only at this point. The Coalition is considering hiring a lobbyist to assist with acquiring Proposition 84 funds; have applied for \$80 million. The Coalition is looking to 2030 and 2050 for the project to be completed. This item will be presented at either a Board Workshop or a Board meeting in December.

General Manager Lamb provided an update on the drought response in acre feet. M&I year to date (October 31, 2010) demand is 6,101 acre feet, or 20.4% less than the M&I allotment. IAWP year to date demand is 371 acre feet, or 47.8%, less than the IAWP allotment. SAWR year to date demand is 230 acre feet, or 23.3%, less than the SAWR allotment. October production in acre feet was 1,064. October rainfall in inches was 4.0. Meters in service in October were 20,497.

#### **ENCINA WASTEWATER AUTHORITY**

Director Poltl reported on the EWA Board meeting which took place this morning. He distributed a copy of a press release regarding Green Power On-site Generation Top 20 List which was presented at the Board meeting. EWA is an EPA certified Green Power Partner; there are approximately 1,300 private and public sector green power partners. The EWA Pollution Control Facility is ranked No. 13 in the "Top 20 On-site Generation" category, with approximately 63% of the plant's power generated on-site.

Director Gentry stated that the next meeting will be held at the ACWA Conference in December.

General Manager Lamb stated that the annual Holiday parade will be held on December 5<sup>th</sup>. Due to the fact this event is not a preapproved event (per Ordinance No. 170), Board approval would be required in order for this event to be eligible for per diem reimbursement. The consensus of the Board, with Director Hannan absent, was that the Holiday Parade be an approved District event eligible for per diem reimbursement.
