However, the Governor, the State Water Resources Control Board and the Department of Water Resources are all considering reinstating conservation cutbacks in January.

They are also closely monitoring the push towards new targets on a statewide basis which would include indoor, outdoor, commercial and agricultural water use.

Director Evans stated that the SDCWA is applying for a \$5.2 million grant to be applied to nine projects within the county for disadvantaged communities.

Director Elitharp reported on the Policy and Finance Committee meeting stating that the committee was provided an update on the CalPERS side fund pay down and the California Employer's Retiree Benefit Trust quarterly report.
